

ISLPED 2026 Camera-Ready Paper Submission

Submission Deadline: June 15, 2026

All accepted papers require the explicit submission of a final (camera-ready) version of the manuscript, even if you do not intend to make any changes to your original submission. You must also complete the ACM Copyright form and add ACM Computing Classification categories and terms to your paper. Author-identifying information, such as author names, affiliations, acknowledgements, and references should be included.

To complete this process, please read carefully and follow the instructions below:

1. Prepare Final Manuscript

Manuscripts should not be significantly modified from reviewed versions unless instructed by the Technical Program Committee.

Step 1. Use the ACM Template

The ISLPED proceedings use the ACM template this year. Papers that use the IEEE template will be returned to the author for correction. Please use the ACM "sigconf" proceedings template. You can download the LaTeX template (strongly recommended) and Microsoft Word template from the [ACM website](#). The [ACM LaTeX template on Overleaf](#) platform is available to all ACM authors.

Do not modify the template, such as the font size, margins, and line spacing. Papers that do not adhere to the template may be returned to the author for correction. All accepted papers (regular papers and posters) should be full-length of up to 6 pages (PDF format, double-column, US letter size, using the ACM Conference format), including all illustrations, tables, and an abstract of no more than 250 words, plus an additional 1 page for references only."

Step 2. Insert Copyright Information

ACM has an automated rights management form collection system for ACM published proceedings. The contact (lead) author(s) will be sent the ACM rights management form and complete instructions on how to complete their form. After completing the rights management form, authors will be emailed the correct rights text and bibliographic strip to place within their paper. Authors must enter the text into their paper.

As rights management emails are sent from an automated system, there is a chance that emails sent will wind up in SPAM folders. Please make sure that you set email SPAM settings to allow emails from rightsreview@acm.org.

Step 3. Insert ACM Computing Classification System (CCS) Categories

The authors should apply ACM Computing Classification categories and terms. The templates provide space for this indexing. The Computing Classification Scheme can be found on the [ACM website](#). If there are troubles finding appropriate categories and subject descriptors, contact Craig Rodkin <rodkin@hq.acm.org> for suggestions.

Step 4. Insert Keywords

The authors should add appropriate keywords. The templates provide space for keywords.

Step 5. Update Manuscript

You may make final updates to your originally submitted manuscript for taking reviewer feedback into account. Major changes apart from those specifically addressing reviewer comments are not permitted.

- **THE AUTHOR LIST MUST REMAIN UNCHANGED.** The author list should be the same as in the paper submission phase. Adding or removing authors, or reordering the author list, is not allowed. However, you may update the corresponding author designation.
- **For Special Session papers:** Paper titles must begin with Special Session, followed by a colon. The title of a special session paper would be **Special Session: Title**.
- **For Design Contest Demo abstracts (up to 2 pages):** Paper titles must begin with Demo Abstract, followed by a colon. The title of a design contest abstract paper would be **Demo Abstract: Title**.

2. Submit the Final Paper

Alongside the camera-ready PDF's, authors are required to collect and submit the source files for each paper – all files which were used to create the final output (PDF), e.g., Microsoft Word, LaTeX, image files, etc. If there are Supplements and Auxiliary Materials, they should be provided in separate zips and labeled as such - aux.zip or suppl.zip.

Submission of source files was always a requirement, albeit one that was hardly enforced in the past. In anticipation of serving both accessibility compliant PDF and responsive HTML5 formatted files from the ACM Digital Library, ACM is now enforcing this requirement.

Submit your final paper PDF (and the source code as ZIP file) through the [SOFTCONF system](#). Please check that the copyright notice in your PDF (only first page) matches the copyright specified in the copyright form (based on author affiliations).

3. Register for the Conference

Each paper requires one full registration at the conference in order to be published. You must register before the early registration deadline. The registration website will be available soon.

4. ACM's New Open Access Publishing Model for 2026 ACM Conferences

Starting January 1, 2026, ACM fully transitioned to Open Access publishing. All papers accepted to ACM-sponsored conferences in 2026 will be published Open Access.

Authors will have two primary options for publishing Open Access articles with ACM: the ACM Open institutional model or by paying Article Processing Charges (APCs). With over 1,800 institutions already part of ACM Open, the majority of ACM-sponsored conference papers will not require APCs from authors or conferences (currently, around 70-75%).

Authors from institutions not participating in ACM Open will need to pay an APC to publish their papers, unless they qualify for a financial or discretionary waiver. To find out whether an APC applies to your article, please consult the list of participating institutions in ACM Open and review the APC Waivers and Discounts Policy.

Understanding that this change could present financial challenges, ACM has approved a temporary subsidy for 2026 to ease the transition and allow more time for institutions to join ACM Open. The subsidy will offer:

- \$250 APC for ACM/SIG members
- \$350 APC for non-members

This represents a 65% discount funded directly by ACM.

To further support authors during this transition, SIGDA will introduce a Financial Hardship Waiver (FHW) program for 2026. The initiative, jointly funded by ACM and SIGDA, will provide a limited number of waivers to cover APCs for eligible SIGDA members who are corresponding authors. More details are available on the [SIGDA website](#). Requests will be submitted after paper acceptance (through the ACM e-rights system) and evaluated by a SIGDA-appointed committee, based on ACM's standard criteria.

5. Present Your Paper

Presentation of the accepted papers/posters at the conference is mandatory. Papers that are not presented will be excluded from publication.

6. Social Media Promotion

Use the [Template 1](#) (without figure) or [Template 2](#) (with a figure of the author or a diagram from the paper) for social media promotion. Add the hashtag #ISLPED2026 so we can follow.
